- 3 The Statutory Auditors of the Company have carried out limited review of the aforementioned unaudited financial results of the company for the quarter ended 30th June 2022 and has given unmodified opnion on the same.
- 4 Provision for taxation under Income Tax Act, 1961 has been made based on the anticipated taxable income for the year as a whole.
- 5 The Company's operations at present are confined to only one segment i.e. providing Financial and Other Advisory Services and accordingly there are no separate reportable operating segments as per Ind AS 108 -Operating Segments.
- The figures for the quarter ended 31st March, 2022 are the balancing figures being difference between the audited figures in respect of year ended 31st March, 2022 and the published year to date figures upto the third quarter ended 31st December, 2021 of the relevant financial year.
- 7 The Figures of the previous quarter/year have been regrouped/rearranged whenever necessary, in order to make them comparable.
